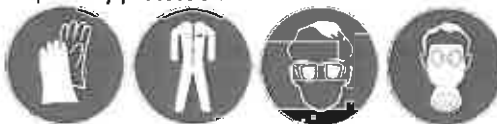
### 8.2. Exposure Controls

#### Appropriate Engineering Controls
