**2. HAZARDS IDENTIFICATION**

**EMERGENCY OVERVIEW**  
 DANGER. CORROSIVE. CAUSES IRREVERSIBLE EYE DAMAGE. CAUSES SKIN BURNS. HARMFUL IF SWALLOWED.

**Principal routes of exposure:** Eye contact. Skin contact. Inhalation.

**4. FIRST AID MEASURES**

**Eye contact:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Get medical attention immediately.

**Skin contact:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Get medical attention immediately.

**Inhalation:** If breathing is affected, remove to fresh air. Get medical attention immediately.
