


Expansion Station Model 12 Setup & Installation Guide

Mounting and Installation

- 1) Attach the mounting feet to the enclosure with the hardware provided. Mount the enclosure on a wall.
- 2) When routing wires into the enclosure:
 - Always use watertight strain relief fittings after making cable routing holes in the enclosure.
 - Do not route the communications wire (data) through the same hole or fitting as the high voltage power wires. This can induce noise in the data line and interfere with communications between the station and controller.
 - When possible cut all holes in the bottom of the enclosure. This prevents water from entering through the holes or fittings.
- 3) Using shielded twisted pair (22 or 24 gauge) cable, connect the EXPAND DAT and DAT + terminals on the station to the DAT and DAT + terminals on the controller's EXPAND terminal block. Connect the cable shield to GND at the expansion station and each controller. Do not tie the cable shield to earth ground at any point.



- 4) Wire your ventilation devices to the CH1 through CH12 terminal blocks. Refer to the **Egg Producer** Controller Installation Manual for more information about wiring ventilation devices.
- 5) Connect the input devices to the input terminals. There are 10 analog and 4 digital inputs available. Refer to the **Egg Producer** Controller Installation manual for more information about wiring input devices.
- 6) Connect the AC power (90 240 VAC, 50 or 60 Hz) to the AC POWER terminals located on the left side inside the enclosure.
- 7) Your expansion station contains many of the same features found in the **Egg Producer**Controller. Refer to the **Egg Producer**Controller Installation manual for more information about channel interlocking and operation of the toggle switches.



Setting DIP Switches

The controller assigns devices (input sensors or output channels) by station and channel number. The host controller is always station address number 1. Begin numbering your expansion stations from number 2.

The switches ADDRESS SELECT 1, 2, 4, and 8 are used to select an address number for the expansion station. Each station must be given a unique number. The controller uses these address numbers to communicate with specific stations. You will need to know the station number when you designate installed devices using the main controller's System & Control Device Set-Up menu.



Note: Actual DIP Switch block orientation and labeling may vary from the example shown.

The table below shows the switch settings for each possible address number. For example, to assign an address number of 2, set the switches as follows: 1 - on, 2 - off, 4 - off, 8 - off.

When the switch positions are changed, remove and re-apply power to the board to reset it (or press the reset switch).

Termination

If the expansion station is at the end of the communications chain (or if it is connected to a single controller) the terminate jumper (JP1) located inside the front cover by the ribbon cable should be installed across pins 1 and 2 (counting left to right).

If the expansion station is not at the end of the communications chain, the terminate jumper should be installed across pins 2 and 3.

You may also need to terminate or un-terminate your controller. Refer to the **Egg Producer** Controller Installation manual for more information about termination for the controller.

Front Panel LEDs

- **Power** Illuminates when power is applied to the station.
- **Transmit / Receive** These illuminate or flicker on and off when the station is communicating with the controller.
- **Output Channel LEDs** -These illuminate when an output channel is turned on either manually or by the controller.
