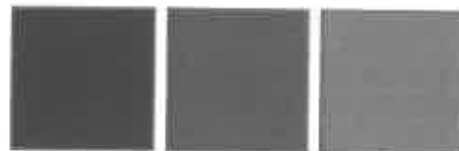

INSTRUCTIONS FOR USE

Use at the rate of 20-30 g/head/day in sows (4-7 kg/ton of feed) for 3-4 week treatments and 100-150 g/head/day in transition cows from 21 days before calving. In lambs use it in a rate of 3-5 kg/ton of feed.

Important:

- Stop feeding after calving.
- Keep a proper Calcium and Magnesium supply in dairy.
- The use of buffers has to be avoided during its application.
- Water should be available at all times.
- Opinion of a nutrition expert or veterinarian should be sought before using the feed or before extending its period of use.
