## 4. First-aid measures

**Inhalation**                                      If dust from the material is inhaled, remove the affected person immediately to fresh air. Call a physician if symptoms develop or persist.

Collect dust using a vacuum cleaner equipped with HEPA filter. Minimize dust generation and accumulation. Avoid release to the environment. Following product recovery, flush area with water. For waste disposal, see section 13 of the SDS.
<b>Environmental precautions</b>	Avoid discharge into drains, water courses or onto the ground.

## 7. Handling and storage

<b>Precautions for safe handling</b>	Provide appropriate exhaust ventilation at places where dust is formed. Minimize dust generation and accumulation. Avoid breathing dust. Avoid contact with eyes. Avoid contact with water and moisture. Keep away from Brominotrifluoride, potassium permanganate, sulfuric acid, nitric acid. Practice good housekeeping.

Store away from incompatible materials (see Section 10 of the SDS). Avoid damp and humid storage facilities, as material is hygroscopic. Keep out of the reach of children.
